

# **Privacy policy**

FXZENITH ("FXZENITH") is a registered company in the Comoros Islands and a brokerage firm licensed in the Comoros Islands. The service name for this website is FXZENITH.

FXZENITH has created this Privacy Policy ("Policy") to govern FXZENITH's use of your personal information, including, but not limited to, users of our website, https://fxzenith.com/, and our products, services and applications, both online and offline. To provide an overview and explanation of how we handle the personal information of individuals, including, but not limited to, users of our website and our products, services, and applications, both online and offline.

FXZENITH (hereinafter referred to as "FXZENITH" or "we" or "us") does not target EU/ EEA clients. Notwithstanding the above, for visitors/clients/users of the website to whom the law of the European Union applies, this Privacy Policy, the GDPR itself and the following legal references to the provisions of the GDPR shall apply.

We may also collect and process personal data lawfully obtained and authorized for processing from publicly available sources such as the Registrar of Companies, the Land Registry, the Commercial Register, the press, the media and the Internet.
